NOTICE OF PUBLIC HEARING

Notice is hereby given that on August 17, 2022, a public hearing, which may be continued or adjourned, will be held by the Ohio Higher Educational Facility Commission at 25 S. Front Street, Columbus, Ohio commencing at 11:00 a.m. local time with respect to the proposed issuance by the Ohio Higher Educational Facility Commission (the "Issuer") of State of Ohio Higher Educational Facility Revenue Bonds (Capital University 2022 Project) as part of a plan of finance in one or more series which may be issued on the same or different dates in a maximum aggregate face amount not to exceed \$45,000,000 (the "Series 2022 Bonds"). The Series 2022 Bonds will be issued pursuant to Chapter 3377 and Sections 9.98 through 9.983, Ohio Revised Code (collectively, the "Act"), for the benefit of Capital University (the "University"), an Ohio nonprofit corporation. The Series 2022 Bonds will be issued as qualified 501(c)(3) bonds under Section 145 of the Internal Revenue Code of 1986, as amended, and the proceeds of the Series 2022 Bonds will be used to finance and refinance costs of acquiring, constructing, equipping, furnishing, installing and otherwise improving "educational facilities" (as defined in the Act, "Educational Facilities") of the University.

The proceeds of the Series 2022 Bonds will be made available to the University to finance and refinance the costs of the Educational Facilities located at or in close proximity to the campus of the University which is located at 1 College and Main, Columbus, Ohio 43209 and at the University's law school located at 303 E. Broad Street, Columbus, Ohio. The University conducts an integrated operation at the foregoing locations.

The initial legal owner or principal user of the Educational Facilities financed and refinanced by the Series 2022 Bonds is the University.

The Series 2022 Bonds will be special obligations of the Issuer and will not constitute a debt or a pledge of the faith and credit or the taxing power of the Issuer or the State of Ohio.

Persons wishing to express their views on the proposed Series 2022 Bonds may submit their views in writing regarding the proposed Series 2022 Bonds and the location and nature of the Educational Facilities to be financed or attend the hearing.
