NOTICE OF PUBLIC HEARING

Notice is hereby given that on October 3, 2023, a public hearing, which may be continued or adjourned, will be held by the Ohio Higher Educational Facility Commission at 25 S. Front Street, 2nd Floor, Columbus, Ohio commencing at 11:00 a.m. local time with respect to the proposed issuance by the Ohio Higher Educational Facility Commission (the "Issuer") of State of Ohio Higher Educational Facility Revenue Bonds (Ohio Wesleyan University 2023 Project) as part of a plan of finance in one or more series which may be issued on the same or different dates in a maximum aggregate face amount not to exceed \$8,500,000 (the "Series 2023 Bonds"). The Series 2023 Bonds will be issued pursuant to Chapter 3377 and Sections 9.98 through 9.983, Ohio Revised Code (collectively, the "Act"), for the benefit of Ohio Wesleyan University (the "University"), an Ohio nonprofit corporation. The Series 2023 Bonds will be issued as qualified 501(c)(3) bonds under Section 145 of the Internal Revenue Code of 1986, as amended, and the proceeds of the Series 2023 Bonds will be used to finance and refinance costs of acquiring, constructing, equipping, furnishing, installing and otherwise improving "educational facilities" (as defined in the Act, "Educational Facilities") of the University.

The proceeds of the Series 2023 Bonds will be made available to the University to finance and refinance the costs of the Educational Facilities located on the University's main campus, the administrative offices of which are located at 61 S. Sandusky St., Delaware, OH 43015.

The initial legal owner or principal user of the Educational Facilities financed and refinanced by the Series 2023 Bonds is the University.

The Series 2023 Bonds will be special obligations of the Issuer and will not constitute a debt or a pledge of the faith and credit or the taxing power of the Issuer or the State of Ohio.

Persons wishing to express their views on the proposed Series 2023 Bonds may appear at the hearing or submit their views in writing regarding the proposed Series 2023 Bonds and the location and nature of the Educational Facilities to be financed and refinanced.
